**2. Storage of Footage After Delivery**

StudioCogan retains completed projects for at least six months after delivery. If files are deleted or lost on your end, please contact us for a resend.

**3. Cancellation Policy & Additional Fees**

- For cancellations, please notify us at least 24 hours in advance to avoid fees (deposits will be retained).
- If overnight travel was required, additional charges may apply.

- **Instant Coverage:** For same-day bookings, rates will be higher. We recommend scheduling at least two weeks to a month in advance.

4. **Delivery**

Editing and finalization typically take one to two weeks post-filming. Once the project is complete, an invoice will be sent via email, followed by the final product. We use services such as WeTransfer, Google Drive, ShareFile, and Dropbox for delivery. If you prefer a different method, please let us know.

5. **Weather**

Our team films rain or shine, though if equipment may be compromised due to weather, we will work with the client to reschedule at no additional cost.
